4. Code of Business Conduct:

This code explains the manner in which we behave as an organisation and how we expect our employees and suppliers to act.

- We may terminate the contract at any time should any instances of modern slavery come to light.

Training

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we provide training to relevant employees.

Our effectiveness combating slavery / human trafficking

We review our modern slavery statement and associated policy on an annual basis and ensure that sufficient steps are taken to prevent slavery or human trafficking in our supply chains. Further, Wharton sustainable solutions ensures any of those associated with Wharton sustainable solutions, including its employees, supply chain and contractors, shall adhere and comply with Wharton sustainable solutions values.
